brian huot's aim for this book is both ambitious and provocative he wants to reorient composition studies view of writing assessment to accomplish this he not only has to inspire the field to perceive assessment generally not the most appreciated area of study as deeply significant to theory and pedagogy he also has to counter some common misconceptions about the history of assessment in writing in re articulating writing assessment huot advocates a new understanding a more optimistic and productive one than we have seen in composition for a very long time assessment as huot points out defines what is valued by a teacher or a society what isn't valued isn't assessed it tends to disappear from the curriculum the dark side of this truth is what many teachers find troubling about large scale assessments as standardized tests don't grant attention or merit to all they should instead assessment has been used as an interested social mechanism for reinscribing current power relations and class systems

while most english professionals feel comfortable with language and literacy theories assessment theories seem more alien english professionals often don't have a clear understanding of the key concepts in educational measurement such as validity and reliability nor do they understand the statistical formulas associated with psychometrics but understanding assessment theory and applying it by those who are not psychometricians is critical in developing useful ethical assessments in college writing programs and in interpreting and using assessment results a guide to college writing assessment is designed as an introduction and source book for wpas department chairs teachers and administrators always cognizant of the critical components of particular teaching contexts o'Neill moore and huot have written sophisticated but accessible chapters on the history theory application and background of writing assessment and they offer a dozen appendices of practical samples and models for a range of common assessment needs because there are numerous resources available to assist faculty in assessing the writing of individual
